the code of criminal procedure, 1973 also provides a way for the courts to exercise their power to grant bail. the legislature has also made it a special power of the courts, which can be exercised to grant bail in certain specified cases. the act provides that the court may, if it thinks fit, grant bail to the accused who is a person who has been convicted on two or more occasions of a non-bailable offence, or who has been charged with a cognizable offence, and who has been previously convicted of an offence punishable with death, life imprisonment, or imprisonment for ten years or more. the above-stated power of the court to grant bail in cases where the accused is a person who has been previously convicted of an offence punishable with death, or life imprisonment, or imprisonment for ten years or more, has been made in section 437 of the code. the power to grant bail to such a person has been made in order to prevent this person from roaming around the streets freely. in such cases, the court may grant bail to the accused if it is satisfied that his release would not be prejudicial to the public safety, or cause inconvenience to witnesses or the public, or be an undue interference with the administration of justice. on the other hand, sub-section 4 of the present section provides for the conditions which may be imposed on the convicted person. it says that while granting bail to a person convicted of an offence which is punishable with imprisonment for a term which may extend to seven years or more or an offence given under chapter vi, xvi, or xvii of the indian penal code or an offence of abetment, conspiracy or attempt to commit any offence given under the above-mentioned chapters, the court may impose the following conditions on the convicted person: -

the second division of the code deals with crimes and offences against property. the third division of the code deals with crimes and offences against the person. the fourth division of the code deals with offences against public order and process. and the fifth division of the code deals with miscellaneous offences. section 436 of the criminal procedure code deals with bail in cases of bailable offences. it states that when any person is arrested or detained by an officer in charge of the police station for a bailable offence without a warrant, and such person when brought before the court of law or himself appears before it, shall be released on bail when he is ready to give bail either while in custody or at any stage of the proceeding. the same was observed in ratilal bhanji v. asstt. customs collector (1967), that a person accused of a bailable offence has on arrest a right under section 436 to be released on bail. sub-section 3 of the present section provides for the conditions which can be imposed while granting bail. it says that the court while granting bail to a person who is accused of or suspected of the commission of an offence punishable with imprisonment which may extend up to seven years or more, or is an offence given under chapter vi, xvi, or xvii of the indian penal code or is an offence of abetment, conspiracy or attempt to commit, any offence given under the above-mentioned chapters shall impose the following conditions:- 5ec8ef588b
