Kostuch, Jr., for the appellee (plaintiff). HOUSE, J. The parties to this action were married on June 30, 1952. There was one child born to the marriage, Kenneth Janowski, born April 26, 1954. In December, 1954, the plaintiff was in a hospital having an operation; and after the operation she was under the care of the defendant Walter Janowski, who visited her at the hospital until she was released. On February 25, 1955, the parties separated. The court found that both *91 parties were guilty of cruel and inhuman treatment toward each other during the marriage. The judgment ordered Walter to pay the plaintiff the sum of \$12,300 for her support, subject to the payment of \$200 each month toward the support of Kenneth. The defendants have appealed to this court, claiming that there is insufficient evidence to support the finding that they were guilty of cruel and inhuman treatment toward the plaintiff. A provision of the same statute, General Statutes §§ 46-48, as was involved in the decision in Ricci v. Ricci, 137 Conn. 579, 582, 79 A.2d 496, is in effect as follows: "In actions for divorce, annulment, for cause destroying the bonds of matrimony, or for alimony and for custody of minor children, the plaintiff may, in addition to her testimony as to the cruel and inhuman treatment, give the testimony of other persons who have been in a position to observe and know of the conduct of the parties toward each other, if it appears to the court that it has probative force on the subject." The question is whether the court should credit, on the
